RELEASE AND WAIVER OF LIABILITY

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING

1. I acknowledge that horse riding can be dangerous and result in personal injury or death and in particular;
 - (a) Horses are unpredictable and may react to the conduct and actions of other riders and persons
 - (b) Horses may without warning kick, bite, stomp, stumble, rear, fall down and react to sudden movements, noises, vehicles or other animals and objects
 - (c) Equestrian activities involve equipment that may break, fail or malfunction
 - (d) Other horse riders may not control their animals, ride or handle their horses within their ability, and cause a collision or other consequence
2. I acknowledge that the rallies organised by the Tuakau Adult Riding Club take place at properties that may contain hazards such as:
 - (a) Plant and machinery
 - (b) Uneven ground
 - (c) Water
 - (d) Livestock
 - (e) Electric fences
 - (f) Open drains
 - (g) Agricultural equipment such as harrows
3. I acknowledge that the items referred to in clauses 1 and 2 are non-exhaustive and that I must exercise care, common sense and due diligence in my use of horses and all related properties at which rallies are held.
4. I acknowledge that I participate in rallies and club activities at my own risk.
5. I acknowledge that on paying a membership fee I will abide by the rules of the Tuakau Adult Riding Club.
6. I must use safety equipment including but not limited to, a NZPCA approved helmet, suitable clothing and suitable footwear while riding horses or entering rally properties.
7. I agree to follow any directions and safety policies given to me by the Tuakau Adult Riding Club and any other venues at which Club rallies are held.
8. I waive any right to claim damages against the Tuakau Adult Riding Club and/or any associated parties in the event I and/or the minor I am responsible for suffer loss or damage of their possessions, personal injury, or death to the maximum extent permissible by law.
9. I agree to indemnify the Tuakau Adult Riding Club and any of its associated parties against all claims made by myself or by anyone on my behalf, arising out of, or related to, horse riding activities that I may engage in or any other related equestrian activities.
10. I agree to pay high regard to the safety of other people and their horses whilst participating in Club rallies and activities.
11. I understand the nature of equestrian activities, my experience and capabilities and believe that I am qualified, in good health, and in proper physical condition to participate in the Tuakau Adult Riding Club's rallies and activities.
12. I have read this consent and agreement, release and waiver of liability, assumption of risk and indemnity agreement. I acknowledge that I have read and fully understand the terms and meaning of this document.
